**MEETING MINUTES**

---

**1. Convene**

President Bill Carrow convened the First General Business Session. The Sergeant-At-Arms verified that only active members were seated in the voting sections of the room.

President Carrow thanked the Quorum for attending the Philadelphia Conference. The Executive Committee and Board of Directors were introduced.

**2. Life Member Voting (Bill Carrow, Brent Lee, Mark Pallans)**

First Vice President Gregory Riddle reviewed the three 2011 life member nominees, asking the nominees to leave the room while the Quorum votes. A motion was entertained to elevate Bill Carrow, Brent Lee and Mark Pallans to the status of life member. Barry Woodward of the Georgia Chapter *motioned* to nominate Bill Carrow, Brent Lee and Mark Pallans for life membership of APCO International. Jim Acosta of the CPRA Chapter *seconded* the motion. No discussion. A verbal vote was taken with no opposition and the motion *carried*.

**3. Address by the U. S. Department of Homeland Security**

Chris Essid, Director, Office of Emergency Communications, US Department of Homeland Security, updated the Quorum on the activities of the Office of Emergency Communications. Improving emergency communications capabilities is one of the department's top priorities. The OEC focuses their efforts on enhancing nationwide interoperability and moves forward by collaborating with the public safety sector. The National Emergency Communications was developed as the nation's first strategic document that addressed interoperable communications. Every state now has a statewide interoperability communications plan, coordinator, and statewide governance body.

**4. APCO Presentations**

Regulatory Update: Bob Gurss, Regulatory Counsel presented an update to the Quorum, reviewing the following topics:

- E9-1-1's status
- Inside 9-1-1 calls and location accuracy for VoIP calls
- Standards for NG9-1-1 issues and transition
- Narrowbanding
- 800 MHz rebranding
- Light Squared
- State and local government agencies are eligible for 700 MHz.

Legislative Update: Sean Kirkendall, Legislative Consultant to APCO, updated the Quorum on the Public Safety Alliance activities and progress, including the allocation of D Block spectrum issue.

ProCHRT: Steve Souder, Chair of the ProCHRT Task Force, gave an overview of research conducted by ProCHRT, covering the current human resource issues facing public safety communications call takers and dispatchers which affects seventy percent of the membership of APCO International.

## **5. Branding Overview**

Dave Clemons, Branding Task Force Chair, reviewed the current rebranding efforts by APCO International.

## **6. Second Vice President Candidate Address**

Mike Jeffres, candidate for the office of Second Vice President, addressed the Quorum at this time. Mike is an officer of the Nebraska Chapter, APCO frequency advisor, chair of the Nebraska 700 MHz planning committees, and routinely interacts with other APCO members around the country on spectrum management issues. His professional experience with the State of Nebraska Chief Information Office is that he manages their public safety program which he built from the ground up. He has worked for twenty two years in public safety communications at the technical and management levels. He believes his greatest accomplishment has been building partnerships. His main desire is to serve and meet the challenges of APCO International.

First Vice President Gregory Riddle clarified parliamentary procedures the association will follow for voting when only one candidate is running for office. Based on a parliamentarian's review of documents adopted in 2009 under the Strategic Governance Implementation (SGI) Task Force, the Executive Committee of the Board of Directors has ordered preparation of written ballots to carry out a vote of acclamation at the Second General Business Session for two offices for which one candidate is eligible for each. In accordance with Bylaws Section 8.6, the incoming First Vice President and Second Vice President shall be elected by a simple majority with the election conducted by members casting ballots.

**MEETING MINUTES**

**1. Convene**
