- Market leader in frequency coordination with launch of the first fully web-based software platform
- Membership is now 15,000 plus
- Inducting the largest class this year of Project 33 certified training program agencies

# State of the Association

APCO Executive Director Derek Poarch gave an overview of the 2012 Annual Report to the Quorum, touching on some of APCO International's notable accomplishments for the year:

- Showed accomplishments were tied to the five Long Range Strategic Plan (LRSP) goals
- Staff uses the Balance Scorecard method to tracks progress on the LRSP goals and is implementing APSTAT (short for APCO Statistics) that will be reviewed monthly during the staff directors' meetings
- Passing of HR 3630 allocation of D-block with funding of up to \$7 billion
- Operating reserves at 43% and total APCO assets at \$7.5 Million
- Alexandria Office Renovation work was under budget, color scheme is blue, white and gray, installed new security system, new conference room on the 3<sup>rd</sup> floor
- Membership growth closing in on 16,000 members; 17% are group members, would

like to reach 20,000 members by next year's conference in Anaheim

- Frequency coordination average of 530 applications per month
- 9-1-1 Adviser Software sales tripled in the last two years
